Soroptimist International of Sacramento North (SISN) is a member of the world's largest business and professional women's service organization, which works to improve the lives of women and girls in local communities and throughout the world. Almost 95,000 Soroptimists in 120 countries and territories contribute time and financial support to community-based and international projects that benefit women and girls. Soroptimist International was founded October 3, 1921 in Oakland, California.

SISN was chartered April 13, 1954. Our members engage in professions and careers and come together for mutual support, friendship, and to serve the community in which we live. Members contribute their time and raise funds for many local and international service projects.

The Service Fund Grant Program is designed to make the most democratic process of choosing how our hard-earned funds will be distributed. Grants are limited to \$1,000 each. Consideration will only be given to requests for specific items or projects which can be fully funded for the requested amount. Requests greater than \$1,000 should be submitted to our Long Range Planning Committee.

General Guidelines

- Limit grant request to \$1,000.
- Request should be full funding of item or project.
- Limit responses to space allowed on application.
- If your organization is tax exempt, submit a copy of the IRS letter ruling with application.
- Grant application may be copied as needed.
- Completed grant applications must be received by November 20, 2020
